

Anderson Elementary Parent & Family Engagement Policy 2018/2019

PART I. GENERAL EXPECTATIONS

Anderson Elementary School agrees to implement the following statutory requirements:

- Consistent with section 1116, Anderson will work to ensure that the required school level parental involvement policies meet the requirements of section 1116 of the ESSA, and each include, as a component, a school-parent compact consistent with section 1116 of the ESSA.

PART II.

DESCRIPTION OF HOW SCHOOLS WILL IMPLEMENT REQUIRED SCHOOL PARENTAL INVOLVEMENT POLICY COMPONENTS

1. Anderson Elementary will take the following actions to involve parents in the joint development of its school parental involvement plan under section 1116 of the ESSA:

- Anderson Elementary will create a Parent Advisory Council (PAC) that will consist of at least one parent and campus representative to discuss and provide advice on all matters related to parental involvement.
- Anderson's PAC will meet annually to review and adjust if necessary the current Parent Involvement Policy.
- Anderson Elementary will employ a Parent Engagement Liaison to ensure compliance with the components written in the Parent Involvement Policy.

2. Anderson Elementary will take the following actions to involve parents in the process of school review and improvement under section 1116 of the ESSA:

- Verbal and email notifications via parent link will be sent home informing parents of the opportunity to be a member of our PAC.
- PAC will meet annually to review and update the Parent Involvement Policy.

3. Anderson Elementary will hold an annual meeting to inform parents of the school's participation in Title I, Part A programs, and to explain the Title I, Part A requirements and the right of parents to be involved in Title I, Part A programs. Anderson will convene the meeting at a time convenient for parents, such as in the morning or evening, so that as many parents as possible are able to attend. Anderson will invite all parents of children participating in Title I, Part A programs to this meeting, and will encourage them to attend, by:

- Written and verbal notifications will be sent home inviting parents to our annual Title I Awareness Meetings.
- The meeting will be held before our school-wide Open House event to ensure greater participation from parents and community members.

4. Anderson Elementary will provide parents with information in a timely manner about Title I, Part A programs. Information presented will include a description and explanation of the school's curriculum, the varieties of academic assessments that are used to measure children's progress, and the proficiency levels students are expected to meet by:

- Parent Conference Day will include discussions of different types of academic assessment used to measure progress.
- Holding awareness meetings on an annual basis such as Children's Museum Night and Gifted & Talented Night.
- Monthly "Coffee Talk w/ Kristin" events will be held to discuss academics assessments as well as other pertinent topics with our school principal.

5. Anderson Elementary will inform each parent about their child's performance on state assessments. Individual reports will be made available upon request to those parents who would like a copy. In addition, parents will be informed on how to access these reports on TEA's website. Students in a grade level with SSI requirements, who do not pass, will be contacted by phone and given the results.

6. Anderson Elementary will take the following actions to provide each parent timely notice when their child has been assigned or has been taught for four (4) or more consecutive weeks by a teacher who is not highly qualified within the meaning of the term in section 200.56 of the Title I Final Regulations (67 Fed. Reg. 71710, December 2, 2002) by:

- Written communication will be sent home to parents of those children affected.

7. Anderson Elementary will provide assistance to parents of children served by the school, as appropriate, in understanding the topics below:

- the state's academic content standards,
- the state's student academic achievement standards,
- the state and local academic assessments including alternate assessments,
- the requirements of Title I Part A,
- how to monitor their child's progress and work with their child to improve academics, and
- how to work with educators:

The following actions will be taken in order to ensure parents understand the mentioned topics.

- Annual Title I Awareness Meeting
- Parent Conference Day
- RTI Meetings
- "Coffee Talk with Kristin"

8. Anderson Elementary will take the following actions to ensure that information related to the school and parent-programs, meetings, and other activities are sent to parents of participating children in an understandable and uniform format. The presentation will include alternative formats upon request, and, to the extent practicable, in a language the parents can understand:

- Written and verbal communications such as the marquee, parent link, school's webpage, PTO Facebook and newsletters will be sent home as needed regarding program participation, meetings, and school or level-wide events.


