**Stelle Claughton Middle School will take the following actions to involve parents in the joint development of its parent involvement policy (section 1112) and the process of school review and improvement (section 1116):**

- Stelle Claughton Middle School will actively recruit parents and caregivers to participate in an advisory capacity.
