PART I. GENERAL EXPECTATIONS

Bammel Elementary School will implement the following strategies to increase meaningful parent involvement to improve student learning:

Coordination of Programs:

To coordinate parental involvement, a Parent Engagement Liaison is designated on the campus of **Bammel Elementary School**. The Parent Engagement Liaison serves as a liaison between the school and the parent. The Parent Engagement Liaison aides in organizing Open House meetings and other programs in which parents are invited to the school to meet with teachers and administrators concerning their child's progress in the school. These meetings are set aside as a time to build and help maintain parent relationships with the school and the teachers.

The Parent Engagement Liaison will meet with The Community Engagement Department Office of Parent Engagement several times a year to maintain parental involvement programs at the school.

Parent's Right-to-Know

The Office of Parent Engagement will compose a letter informing parents of their rights-to-know. This letter is distributed to parents during Open House meetings, in registration packers, and at all other parental involvement meetings.

Students are entitled to instruction by a highly qualified teacher under the No Child Left Behind Act of 2001 (NCLB). **Bammel Elementary School** notifies parents by letter when a child is being taught by a teacher that does not meet the highly qualified criteria of NCLB. Bammel Elementary School also notifies parents by letter when a substitute has been in a classroom for more than four consecutive weeks and does not meet the highly qualified criteria of NCLB.

School-Parent Compacts

Bammel Elementary School, teachers, and parents have jointly developed the School-Parent Compact. Needs assessment results, feedback from parental involvement meetings, and other resources will all be used to make necessary changes to the PIP.
