This application must be submitted for each person (hereafter called "student") under 18 years of age who claims a residence in the Spring Independent School District separate and apart from the residence of the student's parent, guardian, or other person having lawful control of the student under an order of a court (hereafter called "parent, guardian, or court custodian," whether there is one or more).

There are civil and criminal penalties for knowingly providing false information on a student enrollment form, including payment of tuition and criminal sanctions. [See Texas Penal Code 37.10 and Texas Education Code 25.001(h) and (i)]
