- A. Superintendent of Schools
 - Dr. Rodney Watson highlighted the presentations on attendance, literacy, and the first renderings of Roberson Middle School that would follow on the agenda.

- A. Report on Delinquent Property Taxes
 Yolanda Humphrey of Perdue, Brandon, Fielder, Collins & Mott, LLP presented a report on
 the collection of delinquent taxes for the District.

V. Presentations

- A. Roberson Middle School Replacement Design Brendon Hoffman and Kerri Ranney of Huckabee Architects, presented a review of the design of the Roberson Middle School replacement school. The presentation included the interior and exterior perspectives as well as floor plans.
