#### **MINUTES**

#### L Call to Order

Vice President Jana Gonzales called the Regular Board Meeting of the Spring Independent School District Board of Trustees to order at 7:00 PM on February 13, 2018, in the Board Room of the Gordon M. Anderson Leadership Center, 16717 Ella Boulevard, Houston, Texas, in accordance with Chapter 551 of the Texas Government Code.

#### II. Flag Pledges

The Presentation of the Colors was led by the Dekaney Wildcat NJROTC. Cadets Cameron Smith, Carl Koulavongsa, Kurt Koulavongsa, Tanisha Stewart, and Taisha Stewart presented the colors and led the Pledges of Allegiance.

#### III. Moment of Silence

Vice President Gonzales asked the audience to join in a moment of silence.

#### IV. Opening Remarks

#### A. Superintendent of Schools

Dr. Rodney Watson opened his remarks with highlights from the Board Work Session on February 8, 2018 that included a presentation on the new Roberson Middle School replacement campus. He also noted that 45 student athletes from Westfield, Dekaney and Spring high schools participated in National Signing Day, signing letters of intent to play at higher educational institutions. Next, he personally congratulated Gabriella Sucasin, a Twin Creeks Middle School seventh grader, for taking the top spot in the Spring ISD Spelling Bee. He went on to draw attention to a recent article in the Houston Chronicle that noted Spring ISD has the highest average teacher salary of all of the region's largest school districts. In closing, Dr. Watson acknowledged that February is Career and Technical Education Month and talked about the many opportunities for students to explore different careers among the 45 different career pathways offered.

#### B. Board of Trustees

Vice President Gonzales invited the Trustees to make remarks.

Trustee Durant commended the administration at Claughton Middle School for hosting a "great event" on February 12, 2018 in celebration of the school's 15th anniversary.

Trustee Davis asked Dr. Rodney Watson to report on the Houston Area Alliance of Black School Educators (HAABSE) Teacher of the Year event. Dr. Watson said that 14 Spring ISD teachers were recognized at the event and received awards from the HAABSE organization. After thanking Dr. Watson, Trustee Davis went on to congratulate the Dekaney, Spring and Westfield high school basketball teams for an excellent year.

Trustee Bell encouraged those in attendance to make sure they are registered to vote and participate in the upcoming elections, with a reminder that school board elections are held in November.

Trustee Jensen asked Dr. Rodney Watson to report on the Principal of the Year selection. Dr. Watson introduced the 2018 Principals of the Year, who happened to be in the audience – Beneke Principal LaTracy Harris, Elementary Principal of the Year, and Roberson Principal Tracey Walker, Secondary Principal of the Year. Dr. Watson stated that he was proud of the work that the principals are doing which he said is evident in their student achievement and leadership.

#### V. Presentations to the Board of Trustees

A. Presentation of Jostens Youth Matter Donation
Gardner Seaholm, Ph.D., of Jostens, presented a check for \$1,000 from Jostens
Youth Matter to Superintendent Dr. Rodney Watson. Jostens Youth Matter is a
charitable giving program established to support Jostens' customers and the
communities they serve.

## B. Presentation of Proclamation Chief Julie F. Hill presented the Board of Trustees with a proclamation from Senator Sylvia R. Garcia's Office in honor of National School Board Appreciation Month which

was observed in January. The proclamation acknowledged the Board's commitment and notable contributions on behalf of the community in which they serve.

#### VI. Recognitions

#### A. ABCD Award

Chief Tiffany Dunne-Oldfield announced that the recognition of Rabbi Amy Weiss would be moved to a future meeting as Rabbi Weiss was unable to attend the meeting.

#### B. Spotlight

The Board recognized students from Beneke Elementary, Booker Elementary, and Carl Wunsche Sr. High School who participated in activities to honor National Black History Month.

Booker Elementary's Orff Ensemble, directed by Suzette Fears, opened the segment with an African song.

Next, Dawn Ford, a tenth grader at Carl Wunsche Sr. High School presented her artwork titled "Color Blind".

Next, four students from Beneke Elementary School -- Alexandra Smith, Camille Jones, Rodney Watson and Kymani Walsh -- performed a variety of selections to demonstrate how Black History is about inspiration, dreaming, hoping and believing.

To conclude the Spotlight, students from Beneke Elementary School sang a verse of James Weldon Johnson's "Lift Every Voice and Sing".

#### C. Points of Pride

The Twin Creeks Step Team, coached by Lebrandon Jenkins, was presented a Point of Pride award for winning first place in their age group at a national competition in Orlando, Florida, in December 2018. Coach Jenkins said the team started three years ago with 17 members and placed fifth in national competition during their first year. He commended his team members for "a lot of hard work."

#### VII. Chief Human Resources Officer

A. EVERY day counts - Teacher Attendance Program

The Board recognized the 52 Spring ISD teachers who earned \$1,500 incentive awards in the District's inaugural EVERYday Counts attendance drawing. The incentive program is part of the District's strategic compensation work, which recognizes and rewards high performance from every employee.

campuses and future plans for Maker Spaces throughout the District.

Trustee Durant led a discussion on the current policy and practices regarding the

naming of District facilities. The purpose of the discussion was to get feedback from the Board of Trustees for the Board Governance Committee to take under consideration while revising the current policy.

#### X Chief of Staff

A. Approval of the 2018-2019 Academic Calendar Chief Julie F. Hill presented the 2018-2019 Academic Calendar for Board approval. Included in the presentation were the results of a community survey, which drew feedback from nearly 2,500 respondents on two proposed calendar options, A and B. The preferred option in the survey, with more than 70 percent of the vote, was Option B, which was recommended by the Administration for approval by the Board of Trustees.

Trustee Davis moved that the Board of Trustees approve the 2018-2019 Academic Calendar, as presented by the administration. Trustee Adams seconded the motion and the motion carried unanimously.

#### XI. Chief of School Leadership and Student Support Services

A. Memorandum of Understanding between EMERGE Fellowship and Spring Independent School District

Chief Lupita Hinojosa presented information regarding a Memorandum of Understanding between EMERGE Fellowship and Spring Independent School District. EMERGE is a program to prepare high-potential students from underserved communities to attend and graduate from selective colleges and universities from across the nation.

Trustee Adams moved that the Board of Trustees approve the Memorandum of Understanding between EMERGE Fellowship and Spring Independent School District, as presented by the administration. Trustee Durant seconded the motion and the motion carried unanimously.

B. Annual Renewal Contract for College Board Chief Lupita Hinojosa presented information regarding the Annual Renewal Contract for College Board. The contract covers the College Board testing that occurs during the 2017- 2018 school year. This includes: PSAT 8/9, PSAT/NMSQT, and SAT Day.

#### XV. Action on Closed Session Items

Vice President Gonzales reconvened the open session at 10:56 PM.

- A. Trustee Jensen moved that the Board approve the Superintendent's recommendation to terminate at the end of the contract term, the probationary contract of Lashovious Smith as presented in closed session and to authorize the Superintendent to provide notice of the Board's action to the impacted employee pursuant to Chapter 21 of the Texas Education Code. Trustee Durant seconded the motion and the motion carried unanimously.
- B. Trustee Durant moved that the Board declare the term contract of Aisha Taylor to be void pursuant to Chapter 21of the Texas Education Code and approve the termination of her employment with Spring ISD, effective upon the deactivation of her Intern Certificate by the Texas Education Agency. Trustee Durant further moved that the Board authorize the Superintendent of Schools to notify this employee of the action taken by the Board. Trustee Adams seconded the motion and the motion carried unanimously.
- C. Trustee Adams moved that the Board render a final order to terminate the contract of Melissa Ciau and authorized the Superintendent to notify the employee of the action taken by the Board. Trustee Bell seconded the motion and the motion carried unanimously.

D. Trustee Bell moved that the Board issue a school district teaching permit to Valencia Krakue for the purpose of teaching noncore career and technology courses and to authorize the Superintendent of Schools to notify the Commissioner of Education of the Board. Trustee Davis seconded the motion and the motion carried unanimously.

#### XVI. Adjournment

On a motion by Trustee Jensen, seconded by Trustee Durant, the Board unanimously adjourned the meeting at 11:02 PM.
