I. Call to Order

President Rhonda Newhouse called the Work Session of the Spring Independent School District Board of Trustees to order at 7:01 PM on April 17, 2018, in the Board Room of the Gordon M. Anderson Leadership Center, 16717 Ella Boulevard, Houston, Texas, in accordance with Chapter 551 of the Texas Government Code.

III. Moment of Silence

President Newhouse called for a for a moment of silence and announced, "Our former first lady, whom we love and admire, from Houston, Texas, has passed away this afternoon,"

asking attendees to remember the first lady and her family.

IV. Opening Remarks

A. Superintendent of Schools

Dr. Rodney Watson announced that every elementary school in the District is hosting a Prekindergarten and Kindergarten Roundup during the week and encouraged those interested to register at their elementary school.

Next, Dr. Watson expressed his appreciation to the Spring ISD Education Foundation for the "phenomenal time" spent on Monday at the annual golf tournament and fundraiser and thanked the Spring ISD Education Foundation for continually finding ways to support our students with scholarships.

Next, Dr. Watson reminded everyone of the Spring ISD Fun Run and Wellness Fair occurring on May 12, 2018 at Carl Wunsche Sr. High School and Old Town Spring.

During Dr. Watson's monthly update about student attendance, he emphasized the importance of consistency and the importance that our students are at school every day. He noted that Spring ISD has many structures in place to help students comply with attendance requirements including Friday night and Saturday school.

In conclusion, Dr. Watson talked about recently attending the National School Board Association conference with Board Members and noted how it is always good to hear what other school districts are doing to really push the work of not only school improvement, but innovation as well.

B. Board of Trustees

President Newhouse invited the Trustees to make remarks.

Trustee Davis announced that he would be making presentations at both Summer Leadership Institutes scheduled for this summer, one in San Antonio and the other in Fort Worth. As a result of Trustee Davis' commitment to present at both events, Spring ISD will receive two complimentary registrations for the Summer Leadership Institute. The annual training conferences, offered by the Texas Association of School Boards, are designed to offer new and experienced school board trustees the information they need to successfully lead and advocate for their students and their communities.

Trustee Gonzales invited everyone to attend the Spring Livestock Show and Fair scheduled for April 26-28 at the Nagy Pavilion. She noted that FFA and 4-H students would be showing their livestock, and photography and homemade projects entered by the FCCLA students would be on display.

Trustee Durant discussed the Board's attendance of the National School Board Association conference and noted how it provides the Trustees the opportunity to meet continuing education requirements, learn new and innovative practices and also stay day up-to-date on legislation and current affairs.

Trustee Jensen commented on the number of students in the audience who were there to be recognized for their achievements and noted what a fun time of year this is, because the agenda is packed with all kinds of awards and recognitions. Trustee Jensen then shared a recent experience at Carl Wunsche Sr. High School where she had an opportunity to view the student Capstone presentations and noted how

interesting and amazing they were. She recalled seeing a student, Tra'Jain Moore, receiving a \$5,000 scholarship from Planet Ford and thanked Planet Ford for their support.

President Newhouse said she also had an opportunity to attend the student Capstone presentations at Carl Wunsche Sr. High School and was amazed by the awesome job the students had done.

V. Recognitions

A. Spotlight

The Board recognized the Spring ISD students who won awards at the Houston Livestock Show and Rodeo Art Contest. More than 500 students from all Spring ISD schools participated in the contest. After an initial round of judging at the district level, Spring ISD submitted 25 pieces of high school art, five pieces of middle school art and five pieces of elementary art to be judged by Rodeo Art representatives at NRG Center. Twelve of our 35 regional qualifying artwork selections won awards. Special Merit award recipients were Cristal Mendoza, Dekaney High School; and Brittney Artola, Fernanda Herrera and Oralia Cantu, all from Westfield High School. Hannah Nguyen, Reynolds Elementary School, won a gold ribbon award. Three students received a gold medal award: Qasim (Aseem) Abdus-Samad, Claughton Middle School; Lauryn Bledsoe, Westfield High School, and An Nguyen, Spring High School. The Best of Show winners were Jahir Salgado, Meyer Elementary School; Cassandra Paredes, Dueitt Middle School; and Kherryn Lapuz, Dekaney High School.

In addition, the Board recognized Jaime Guadarrama from Dekaney High School. He received a Gold Medal and advanced to the auction where his artwork, titled Tribal Chief, sold for \$20,000.

B. Spotlight

The Board recognized the District winners of the Spring ISD 4th Grade Writing Conferences. In March, the District held its first ever 4th Grade Writing Conference at Hoyland and Marshall elementary schools as part of an effort to help scholars better prepare for the 4th grade STAAR test as well as develop skills and strategies that assist writers in becoming proficient authors. Scholars used their artistic experience through arts integration to free write, a process described in Juan Felipe Herrera's book, "Jabber Walking." The two top scholars from each campus were crowned "True Jabber-Walkers" because they combined the break-out conference STAAR test skills they were taught with the skills taught in Juan Felipe Herrera's book. The Board recognized the winners from Marshall Elementary, Kai'tiera Arceneaux and Brenden Rico, and the winners from Hoyland Elementary, Johan Santana and Sirena McGlown. Besides being presented with a medal, the students each received a writer's toolkit, complete with pencils, highlighters, a journal and books.

C. Spotlight

The Board recognized the 3rd Annual Spring ISD Elementary and Middle School Spanish Spelling Bee winners. Six students were recognized for winning the District Spanish Language Spelling Bee held earlier this month at the Gordon M. Anderson Leadership Center. Fourth and fifth grade students competed at the elementary level while sixth, seventh and eighth graders competed at the middle school level for the opportunity to advance to the 8th Annual, 2018 National Spanish Spelling Bee on July 15-17 in San Antonio. The elementary winners were Orlando Santamaria, First, Ponderosa Elementary; Amy Valladares, Second, Clark Intermediate and Raudel A. Delgado Merino, Third, Beneke Elementary. At the secondary level, the winners were

Joshua A. Duque, First, Roberson Middle School; Emiliano Torres, Second, Wells Middle School and Shirley G. Luque, Third, Claughton Middle School.

D. Spotlight

The Board recognized the Texas French Symposium: "Les Annèes Folles" Spring High School participants. The students participated in the Texas French Symposium that was held at The Woodlands High School in Conroe ISD on March 8. The event drew high school students from across the state competing in different categories related to the French language such as prose, poetry, sight reading and guided speaking, art, and grammar. In addition, every student had to take a written exam. The District brought a team of eight students from Spring High School under the direction of Adrian Rodriguez-Camirillo, who was recently named as the 2018 Secondary Rookie Teacher of the Year. The Board got an opportunity to learn about the team's achievement and hear in French and English from Daniel Martell, who placed as a semi-finalist in the categories of prose, poetry and sight-reading. The other students on the team and their accomplishments were: Nathalie Delgado, semi-finalist in prose and poetry; Brian Addington, semi-finalist in prose, sight-reading and tied for 5th place in the civilization test; Samantha Aguilar, semi-finalist in poetry, sight-reading and tied for 5th place in the civilization test; Zoe Taylor, semi-finalist in prose and sixth place in the civilization test; Frida Rivera, semifinalist in guided speaking, sight-reading and second place in the civilization test. Students Alondra Morales and Ezaria Dillard, each received participation certificates.

E. Spotlight

The Board recognized the 4th and 5th grade District winners of the Spring ISD Oratory Contest. Trustees got the opportunity to hear some of the winning speeches from the District's Celebrating Diversity Oratory Content held April 5 at McNabb Elementary. The competition had students address the question "How can we start to eliminate prejudice and inequality in society and start treating everyone with dignity and respect?" Coordinated by campus Literacy Specialists, individual schools held their own contests leading up to the district event, with the winning speeches from each campus' fourth and fifth grade eligible to compete at the district level. The first place winner in the fourth grade division was Elizabeth Carpenter of Ponderosa Elementary. The first place winner of the fifth grade division was Nailah Mensah of Reynolds Elementary.

F. Spotlight

The Board recognized the District winners of the She Persisted essay and project contest. The Grand Prize winners were recognized by the Trustees for their work to celebrate notable women leaders and educators. The theme of the contest was based on the book "She Persisted: 13 American Women Who Changed the World" by author and former First Daughter Chelsea Clinton. The contest was in celebration of Women's History Month and was a collaboration among the Literacy, Social Studies and Advanced Academics teams. More than 300 students submitted projects for judging. Scholars had to choose a woman in history who accomplished something amazing in spite of difficulties. The scholars first had a campus-based competition, then those winners competed against other campus winners in the District competition. The three grand prize winners recognized were Zharaya Walker of Anderson Elementary, Isabel Rincon of Roberson Middle and Jasmin Dominguez of Wunsche High School who spoke about her decision to draw the mother of Spring ISD employee, Patric Francis as a way to repay him for all he does for the students at Wunsche. The students and Trustees saw a personalized video from Chelsea Clinton congratulating the winners for their achievement.

G. Points of Pride

The Board recognized the Spring ISD Procurement Department for receiving a Texas

Association of School Business Officials Elite Award of Merit. The Procurement Department was one of only two districts to receive the Elite Award of Merit for Purchasing Operations at the annual conference awards luncheon of the Texas Association of School Business Officials (TASBO) on March 2. Spring ISD was recognized in the large district staff category. In total, TASBO recognized 30 school districts for following best practices in the area of purchasing operations at the event.

Trustee Durant further moved that the Board authorize the Superintendent of Schools to notify this employee of the action taken by the Board. Trustee Jensen seconded the motion and the motion carried unanimously.
- E. Trustee Gonzales moved that the Board approve the Superintendent's Contract as discussed in closed session. Trustee Durant seconded the motion and the motion carried unanimously.
