I. Call to Order

President Rhonda Newhouse called the Regular Board Meeting of the Spring Independent School District Board of Trustees to order at 5:08 PM on December 11. 2018, in the Board Room of the Gordon M. Anderson Leadership Center, 16717 Ella Boulevard, Houston, Texas, in accordance with Chapter 551 of the Texas Government Code.

VI. Moment of Silence

President Newhouse asked the audience to join in a moment of silence.

VII. Opening Remarks

A. Superintendent of Schools

Superintendent Rodney Watson opened his remarks by inviting everyone to attend the District's annual Winter Wonderland event at Dekaney High School on Friday, December 14th from 5:30 to 8:00 PM. "We're going to have arts and crafts, storytelling,

entertainment and lots of activities for the families of our pre-K through 8th-grade students," he said. He thanked the Spring ISD Education Foundation for supporting the event and ensuring that every child who attends will take home a wrapped book. "Our goal with this event is to continue to build literacy skills among our students," he said. "The great thing about Winter Wonderland is that the kids are having so much fun, they don't even know they're learning."

Dr. Watson also thanked all employees who have taken the District's fourth annual Employee Engagement Survey and encouraged any staff who have not taken it, to do so before the end of the week, when the survey closes. "We're going to share the results in February and it will help us determine areas of focus for the 2019-20 school year," he said. On the topic of surveys, he noted that the District's fourth annual School Quality Survey will open on January 14th. That survey, he noted, will get feedback from all of our families, as well as staff and secondary students. "We'll share that data with you in May," he said.

Dr. Watson then noted that staff and student families will be asked for their feedback on two proposed calendar options, which will be posted to the website in January. "I want to note that the options being presented don't look like a traditional school calendar," he said. "These proposed calendars are designed to maximize the time students spend in the classroom while ensuring both our students and teachers get much-needed breaks throughout the year." He encouraged everyone to review the options and let the District know their opinions.

Dr. Watson then offered a brief recap of the fall Gifted and Talented Expo at Carl Wunsche Sr. High School on November 29th, with 200 students and their families turning out. "As you all know, one of our strategic priorities this year is making sure we're meeting the needs of all of our GT scholars, and this expo is a great way to provide additional enrichment opportunities," Watson said. He added that the District will host another Expo in the Spring, and concluded by showing a brief video.

Dr. Watson then introduced Dr. Kevin Banks, the new principal of the Spring Leadership Academy, formerly referred to as Middle School #9. The new middle school is slated to open in August 2019 in the facility being vacated by the District's Spring Early College Academy, which is relocating to the campus of Lone Star College - North Harris. The new specialty school will offer a leadership program and a blended-learning environment. Dr. Banks has been with Spring ISD since 2013, first serving as assistant principal and most recently as the associate principal at Dr. Edward Roberson Middle School. He began his career in education in 2009 at the Contemporary Learning Center High School in Houston ISD. He later transitioned to Aldine ISD where he worked with the Career and Technical Education program at Aldine Middle School and was named Teacher of the Year in 2012-13. He has a Bachelor's degree in Business Administration from the University of Houston, a master's degree in Educational Leadership from the University of St. Thomas and his doctorate in K-12 Professional Leadership from the University of Houston.

B. Board of Trustees

President Newhouse invited the Trustees to share remarks.

Trustee Gonzales thanked the District for the number and variety of activities featured on the District's social media channels, "There are a lot of exciting things going on, from athletics to curriculum to our performing arts, so please, I encourage you guys to

go on social media. I am so proud to be a part of this District. There is something for every student in our District," Gonzales said.

Trustee Adams congratulated the "Westfield Mustang Football Program, Coach Meekins and the young men that did us really proud this past week at the playoff game." Adams also complimented the Performing and Visual Arts department on the recent Spring High School choral performance. "Again, I continue to be impressed and brag on how outstanding our performing arts program is in the District. Dr. (Joe) Clark, I really appreciate it. He also put a plug in for the upcoming PVA collaborative performances -- The Greatest Winter Show -- that will feature the theater, dance, choir and band students from across the District, including one of his own children. "I want to invite everybody to come out and enjoy what we do in Spring."

Trustee Bell reported on the District's participation in the history-making transport of President George H.W. Bush on the special Union Pacific 4141 funeral train on December 6th. "We experienced, this week something historical, and Spring was able to play a part in it," Bell said. "The train that took his remains to Texas A&M -- the Bush Library -- started right here in Spring, and a number of our students, faculty and staff, and residents were out to take part of a very historical occasion. We want to thank all those who made it happen for our students to be out and be part of history, not just something to read about in a book but to actually be part of history."

President Newhouse thanked Trustee Davis for representing Spring ISD at the Texas Association of School Boards Leadership TASB Class held recently in Amarillo. "Don, we are proud of your service to TASB and to the Board and to the students of Spring ISD.
